

TERMS & CONDITIONS

Powell's Photography (The Company) shall be the sole professional (still) photographers at the venues specified.
By Booking & Paying your deposit you agree to the following terms & conditions stated clearly below.

All details of the wedding & event coverage will be planned in consultation with the client either in person or by phone or electronic communication Powell's Photography will edit every photo and deliver what he considers to be the best of every situation covered.

As a result, contact sheets (or their digital equivalent Web Gallery) will only be supplied to the client in exceptional circumstances. Images of no value, i.e. Pictures with poor expressions, Blinking etc shall be deleted.

If bought in products (for example, albums or photo mounts) (are in the unlikely event) not available to the exact specification as initially discussed Items of equal & or superior quality will be substituted at no extra cost to the customer/client

In the event of illness, incapacity or any unforeseen circumstances, which would prevent Powell's Photography from carrying out the commission. We will make every effort to find a replacement photographer but no guarantee can be given. If a replacement photographer cannot be made available liability shall be limited to a full refund of all monies paid.

Every care is taken in photographing and processing using professional materials. In the unlikely event of total photographic failure i.e. during exposure or processing, the photographer's liability shall be limited to a full refund of all monies paid. We have in place full liability & Indemnity Insurance. (A copy of which can be requested & will be disclosed at Powell's Photography's discretion).

A deposit of £100 will be required at the time of booking (Weddings only) the selected service.

The deposit will be deducted from the total cost of the wedding service. The deposit is not refundable in the event of cancellation.

If a cancellation is received less than THREE MONTHS prior to the wedding date, the full amount will become payable.

The booking is not confirmed until a full deposit is received.

All Wedding packages are to be paid in full 4 – 6 weeks before the selected wedding date.

A fee of £20.00 will be made for each account reminder, duplicate invoice, or any other paperwork, correspondence or phone calls involved with the perusal of a debt. This fee is non-refundable, and represents the additional time spent pursuing overdue invoices.

Cancellation Conditions & Charges Policy

12 months before wedding date no monies are payable £100 deposit paid on booking is NON REFUNDABLE

7 - 11 month before wedding date 20% of the overhaul value of Chosen package in addition to the NON REFUNDABLE DEPOSIT

6 – 4 Months before wedding date 35% of the overhaul value of chosen package in addition to the NON REFUNDABLE DEPOSIT

3 Months or Less Full Amount is Payable to Powell's Photography *"However this maybe reduced to 50% or even waived in extreme mitigating circumstances"*

If a customer wishes to reschedule their date. They may do so in writing or [E-Mail](#) If the date rescheduled is within a 12 month period from original booking date then the deposit paid will be transferred, If any price increases have occurred then the new "current" price will be charged. If the reschedule is over 12 months from original date the deposit can not be transferred and will have to be repaid and rebooked at current prices
